Dear Parents/Carers,

Happy New Year to you all.

Thank you all for your well wishes and support. We are working incredibly hard to secure the smoothest transition for our children's move to online learning, and the onsite provision for Key Worker and vulnerable children.

Having now met with staff, I am sure they would agree it is an anxious time for us all. However, we are keen to support the National effort as best we can; endeavouring to keep everyone as safe as possible is outlined as the community's number one priority.

We also understand how challenging the next few weeks will be for the vast range of our families, juggling work and online learning. We will do everything we can to support you in making the children's engagement as independent as possible. Please ensure, should you experience device or internet issues, that you let us know and we will do everything we can to help.

As a community, we will do everything we can to keep our children flourishing, providing opportunities to see their friends and class teachers.

Later today, parents who have requested a place will receive confirmation by email. Parents are requested to provide proof of their work identification and timetable. Where there is an adult at home, we ask that parents do not send their children into school. The onsite provision is for childcare purposes: the same education will be provided remotely to all children.

It is vital that we do everything to reduce the number of children required to be onsite, primarily to protect the health of our children and staff, but also to ensure we are all comfortable with the arrangements as, essentially, if we do not have the staff, we cannot open.

We have also updated the Risk Assessment and 'Parent Principles'. This will be shared with those parents who are using the onsite provision over the next few weeks.

At the moment, we are planning this alternative provision for the next two weeks, until we receive further guidance from the government.

Remote learning will be available from Google Classroom from tomorrow at 9am.
